9. DETAILS:

On October 28, 1991, a bomb exploded at 39 Eastbourne Street, Roslindale, MA. As a result of the explosion, one police officer was killed and another critically injured.

This investigation has proceeded to a point where all investigative techniques have been exhausted. It is now anticipated that a Title III court ordered intercept will be obtained in the near future, hopefully by Friday, February 28, 1992. This court order will authorize the electronic interception of Alfred Trenkler's voice mail electronic pager. Alfred Trenkler is a key suspect in this investigation and may have constructed the explosive device. Trenkler's pager number is 617-553-0778. ATF currently has in place a clone pager for this number. However, since Trenkler's pager has a voice mail feature, we do not have access to his voice mail messages, therefore, we are now seeking the court ordered Title III intercept.

The affidavit in support of this court order was forwarded to Chief Explosives Division on February 24, 1992.

V. Additional Information:

Metromedia has advised ATF that they would furnish a "clone pager" which would also have access to the voice mail feature. The Special Agent monitoring the clone pager would, upon receipt of a page, be able to call the voice mail number and obtain the voice mail message. The voice mail message, which is stored in a computer, automatically erases itself after seventy-two hours. It is anticipated that the Special Agent monitoring the clone pager would record via an induction coil all voice mail messages. These voice mail messages would be recorded periodically throughout the day.
