9. DETAILS:
 REPORT OF INTERVIEW
 With Joe Pelfrey, on February 27, 1992, telephonically, by Special Agent Dennis Leahy, Bureau of Alcohol, Tobacco and Firearms, Boston Field Division. Mr. Pelfrey states as follows:
 Mr. Pelfrey said that he is the Director of Security for the First Church of Christ, Scientist and that at the request of Special Agent Dennis Leahy that he had reviewed the key control log, temporary badge log and the master security log for the names of Thomas Shay and Alfred Trenkler with negative results. Mr. Pelfrey also said that the surveillance cameras surrounding the buildings at the church property do not contain video tape to record, nor is there a date, time generator in the cameras.
 Mr. Pelfrey said that several weeks ago Bill Mac Namara, an employee of the church, called him and said that Al Trenkler had telephoned him and asked if the church had any records of him (Trenkler) visiting the church. Mr. Pelfrey also said that he was told by Mac Namara that Trenkler said that he was being called before a grand jury.
