REPORT OF INTERVIEW

With Dwayne Armbrister, Radio Shack employee, 197 Mass. Ave., Boston, MA. on March 10, 1992, by Special Agent Sandra R. LaCourse, Bureau of Alcohol, Tobacco and Firearms.

On March 10, 1992, S/A LaCourse showed Dwayne Armbrister a photo array including a photo of Rich Brown and was asked if he recognized anybody in the array. Mr. Armbrister stated that he hadn't seen any of the individuals contained within the array. At this time, S/A LaCourse asked Mr. Armbrister if had remembered anything else regarding the sale to SAHY JYT on 10/18/91. Mr. Armbrister stated that the customer was a tall, white guy who was taller than him. He stated that he was 6'2" tall.

It should be noted that at the time Dwayne Armbrister was first interviewed on February 20th and 24th, 1992, he was unable to recall the description of the customer known as SAHY JYT. When shown a photo of Shay Jr., he stated that he believed that he had seen him in the store before but couldn't remember when. He further stated that he believed that he was wearing Jeans and a sweatshirt when he was in the store.
