REPORT OF INTERVIEW

With Fred Burke, 545 Sanchez Street, San Francisco, California, on March 26, 1992, at 1500 hours, by Special Agent Dennis P. Leahy, Bureau of Alcohol, Tobacco and Firearms, Boston Field Division, and Detective Frank Armstrong, Boston, Police Department, Homicide Division. Mr. Burke states as follows:

Mr. Burke said that he first met Thomas A. Shay (Jr) on February 21, 1992, at about 2:00 P. M. as Shay had a sign on him and was sitting in the rain on Castro Street, in San Francisco. The sign said my lover was killed by gay bashers and my father found out I was gay and threw me out I'm hungry and can you help me? Burke said Shay introduced himself as "James Keough" just thrown out of the military for being gay. Burke said that he brought Shay to his residence and fed Shay and let Shay keep his duffel bag and other things in the basement.

Burke when shown a photo spread immediately picked out Shay (Jr) aka James Keough. Burke said that Shay's (Jr) things were in a green duffel bag in the basement, Burke however refused to let S/A Leahy or Det. Armstrong view the contents of the duffel bag.

Burke said that Shay (Jr) told him his true name after several weeks and said that someone had tried to kill his father with a bomb, someone who had gambling connections and later said that my father was not involved in gambling it must have been some "sicko".
