9. DETAILS:

This report pertains to ATF's investigation into the October 28, 1991 bombing which occurred in Roslindale, Massachusetts taking the life of Boston Police Department Bomb Technician Jeremiah Hurley and critically wounding Bomb Technician Francis Foley.

On February 19, 1992 Special Agents Thomas D'Ambrosio and Jeff S. Kerr interviewed Todd C. Leach, DOB: 11/14/75, S.S # ██████████. Leach resides at 18 Granview Avenue, Quincy, Massachusetts.

Leach stated that he met Alfred Trenkler when he (Leach) was approximately eleven years old. He stated that he believed this to be 1986. He stated that Trenkler often associated with an individual he knew as Bob LNU. He stated that one time he was in a vehicle with Trenkler and Bob LNU and that Trenkler drove to a Radio Shack located in North Quincy, Massachusetts. He stated that Trenkler and Bob LNU wanted to remain in the car and do a line of cocaine so Trenkler gave him (Leach) a list of items to buy from the Radio Shack

Leach stated that he was taking a long time finding all the items Trenkler had on his list. He stated that Trenkler walked into the store and said, "Never mind, I'll buy the stuff". Leach stated that he believed Trenkler spent approximately \$ 150.00 on wires. Leach stated that the man in the store said, "What are you doing, building a bomb?"

Leach stated that while he was with Trenkler at a housing project in East Weymouth, Trenkler observed a discarded stereo speaker and told him to take the speaker apart and to remove the speaker magnet.

DETAILS (Continued)

Leach stated that he remembered seeing Trenkler working on a remote control car. He stated that Trenkler told him that he was making sure that the car could only go in one direction and not reverse.

Leach stated that Trenkler also associated with an individual named David Noonan. He stated that Noonan would be able to obtain explosives.

Leach stated that he remembers getting into a car with Trenkler and Bob LNU. He stated that they were going up to New Hampshire to ride four-wheel recreational vehicles. Leach stated that shortly after departing, Trenkler said that he had to stop. He stated that they stopped and Trenkler exited the vehicle returning shortly there after. He stated that as they began to drive away Trenkler said, "Shit, it didn't work, I have to go back". He stated that Bob LNU was angry and that he believes they turned around and returned to where they had previously stopped.

This investigation is continuing.
