## 9. DETAILS:

On April 17, 1992, Thomas A. Shay attended a hearing before Judge Anthony Sullivan in Boston Municipal Court, at which time Shay's attorney, William C. McPhee, argued that Shay was not competent to stand trial. Shay is currently awaiting trial for falsifying a bomb threat, which he allegedly made to the Back Bay MBTA station in November of 1990. Shay also has a second charge of falsifying a bomb threat pending against him in Brighton District Court for the threat he made, via telephone at the Suffolk County Jail, to a Brighton woman on April 5, 1992. At the close of the hearing, Judge Sullivan scheduled a competency hearing for April 22, 1992 and a probable cause hearing for April 27, 1992. Shay is currently being held at the Suffolk County Jail on \$100,000 cash bail.

On this same date, at approximately 4:15 p.m., Alfred Trenkler was arrested, without incident, on Boylston Street in Boston by ATF agents and the Boston Police. Trenkler was arrested on an outstanding Rhode Island warrant for larceny over \$1000. Subsequent to his arrest, Trenkler was held at the Boston Police Area D4 lockup until April 19, 1992. On that date, at approximately 3:00 p.m., Trenkler was released on bail by a Judge Shubow. An extradition hearing has been scheduled for April 21, 1992 in the Boston Municipal Court.
