**REPORT OF INTERVIEW
(SUPPLEMENTAL)**

With Thomas A. Shay (Jr) on March 24, 1992, at 0400 hours, at Central Police Station, Vallejo and Powell Streets, San Francisco, California, by Special Agent Dennis P. Leahy, Bureau of Alcohol, Tobacco and Firearms, Boston Field Division and Boston Police Detective Brendan M. Craven, Homicide Unit. Mr. Shay states as follows:

Mr. Shay, after a period of silence in response to no question, turned to S/A Leahy and Det. Craven and stated that his lawyer had advised him that he "would not serve big time" because of his history of having been placed in homes and institutions. Shay then asked "What about that Holtz guy, who killed the teenage girl?" After a moment, Det. Craven responded, "You mean Meinholtz, back in Boston?" Shay replied, "Yeah." Det. Craven then told Shay that Meinholtz (who had raised an insanity defense in his recent murder trial) had been found guilty of murder in the first degree. Upon learning this, Shay appeared angry.

Shay then asked, "What about the guy who flew the airplane, shooting out the window?" Det. Craven understood this to refer to a relatively recent Boston-area murder case, involving an individual named Hunter, where insanity had also been raised as a defense. Det. Craven replied, "Murder in the first degree." Shay again became visibly upset at this news.

After a minute or two had passed, Shay said, "I guess I am going to be getting a lot of sex in the can." Shay went on to say that he could

handle being in prison and that he would protect himself by "finding the toughest guy" and punching his roof in"; in this way, Shay explained, the other prisoners would leave him alone.
