But I just sat back down. Kirby got up in ten minutes and asked to use the bathroom and was also refused. Then he said he wanted to smoke a cigarette. The officer put down his cigar, stamped and walked up to Kirby and went up to his face and said too bad. Kirby said just open my father door officer morelli said ok open 68. The second CO did and as morelli shut the door, he said ok asshole you're in for the night. Then said loudly anyone else need to use the bathroom (as in does anyone else want a lock in) after that officer morelli because real suspicious and said to me, what did you say I said I didnt say anything. Because I did not. Brown in Rm. 5565 is my witness to today's events. Sincerely Thomas Shay

IT was about 7:30 PM when OFFICER (DMORELLE)
approached MR. Thomas A. Shay and the other inmates
and told us that he wanted to watch The Bruins
Game. when we and other inmates told him
that we wanted to watch a movie at 8 PM. He
said that we could not. That he runs the Show.
I took command and wrote a letter to the Lt. Larkin.
When the Lt. read the letter & he told the officer
that it was our TV. and we could watch what
we wanted. The officer knowing that I had written
the letter. made my night a little more harder.
First while watching TV. He said that he was writing
an incident report and would see me on the
Sixth Floor which is the whole. Then (he said
what did you say with a loud tone.) I didn't
say anything. and then told him that I didn't.
Then with a loud tone he constantly said (what
are you looking at. at this point the officer told
me to sit up and not to move the furniture (I
(didn't even move) when Lt. Larkin came back
she asked what was bothering the officer said
OHH. That was Shay burning something (I had not
moved from that chair for 2 hours) at that point
I asked the Lt. IF I could fill out an incident report
then the officer replied and said that are you
threatening me. I said no I'm writing an

He made me feel that there was aggressiveness to challenge me to see IF he could push me enough to make me take action against him. He made me feel like he wanted to take action against me and do bodily harm to me. Those are the main reasons of this letter. There are 3 copies other than this one. One on the way to STELLY MURPHY OF THE HERALD. The second to my lawyer. The third to PAUL WATRELLY, ASSIN. US ATTORNEY. IF you don't take action. The Press, my attorney, and Paul Watrely, an (Investigator) on the evidence of Harm from OFFICERS TO MYSELF. So Mr. RUFFO IT IS UP TO YOU. OR THE 3 ABOVE TO TAKE ACTION. Thank you
