

INTERVIEW WITH MRS NANCY SHAM OCT 7 1992

MRS SHAM STATES

- ① PRIOR TO OCT 28 1991 BOMBING @ 2:00AM SHE SAW AN UNKNOWN MALE SLEEPING ON THE COUCH IN HER LIVINGROOM
- ② MRS SHAM BECAME ANGERED AND ORDERED (JR) TO GET THAT FUCKING GUY OUT OF HER APARTMENT NOW.
- ③ SHE RETURNED HALF WAY DOWN THE STAIRS TO REINFORCE THE ORDER
- ④ SHE OBSERVED A SHORT BACKING MAN AND HE, ^(ALTRUNKER) TURNED TO (JR) AND SAID THEY SHOULD LEAVE BECAUSE JR'S MOTHER WAS ANGRY.
- ⑤ SHE SAYS THAT JR AND THE MAN LEFT AND THAT JR DID NOT RETURN UNTIL THE FOLLOWING DAY.

- ① MRS SHAM WAS REFERRING TO A DAY IN JUNE ^{TOM SHAM MOVED} (SEE FOURTH MEETING - JUNE 1991) WHEN (JR) LIED TO ME ABOUT A PARTY AT A FRIENDS HOUSE IN NAHANT, LEFT NAHANT AND RETURNED TO HIS MOTHER'S HOUSE (THE FALLS IN QUINCY) ABOUT 5:30 TO 6AM.
- ② I HAD SAT ON A COUCH AND FALLEN ASLEEP TO AWAKEN TO (JR) AND HIS MOTHER ARGUING ABOUT JR MOVING TO NEW YORK AND NOT WANTING HIM TO ~~SAY~~ STAY IN QUINCY AT HER HOUSE.
- ③ SHE WENT UPSTAIRS AND BEFORE SHE CAME BACK DOWNSTAIRS I HAD LEFT ALONE ^④ STATING THAT HIS MOTHER WAS ANGRY AND
- ⑤ I SHOULD GO AND I DID, ALONE. THIS OCCURED ABOUT 9:00AM - I RETURNED TO 133 ATLANTIC STREET QUINCY. DURING THE ARGUMENT I HAD SAID HELLO TO MRS SHAM AND SHE SAID HELLO BACK - SHE WAS NOT MAD AT ME.
