THE STATEMENT REGARDING THAT I BUILT THE BOMB IN A SHED ADJACENT TO A TOWER IN QUINCY OR THE SOUTH SHORE AREA, FIRST, THERE ARE A LIMITED NUMBER OF TOWERS IN QUINCY, THE ONLY TWO THAT I CAN THINK OF WOULD BE AT THE QUINCY QUARRIES, ONE BEING CERULAR ONE WHICH HAS A STUCCO BUILDING NEXT TO IT AND BOTH TOWER AND SHED ARE SURROUNDED WITH A FENCE. THIS SITE I DO NOT OR ~~NEVER~~ <sup>OR NEVER BEEN IN</sup> EVER HAD ACCESS TO. THE SECOND WOULD BE THE MCI TOWER ALSO AT THE QUINCY QUARRIES BOTH TOWER AND SHED ALSO SURROUNDED WITH A FENCE AND ALSO WHICH I DO NOT OR ~~NEVER~~ <sup>OR NEVER BEEN IN</sup> EVER HAD ACCESS TO. AS FOR ANYWHERE ELSE IN THE SOUTH SHORE, I HAVE NEVER BEEN IN ANY SHEDS NEXT TO RADIO TOWERS NOR EVER HAD ANY ACCESS TO THEM NOR HAVE I EVER BEEN IN ANY. AS FOR SHEDS NEAR 50 FOOT ELECTRICAL TOWERS IN THE WYMOUTH AREA, I AM NOT AWARE OF ANY IN EXISTENCE.

AS FOR SHAY'S STORY ABOUT THE BOMB IN MY TRUNK, I THOUGHT THAT IF IT WAS IN MY CAR - ESPECIALLY IN AN ENCLOSED AREA - THAT THE CARPET SAMPLE WOULD HAVE SHOWN PRESENCE OF DYNAMITE.

AS FOR THE BOMB BEING ATTACHED TO HIS (SHAY SR'S) CAR A COUPLE OF DAYS BEFORE THE EXPLOSION WHILE THE BUICK WAS PARKED IN THE VICINITY OF THE WALTHAM TAVERN IN THE SOUTH END, FIRST SHAY SR'S CAR WAS ONLY AVAILABLE FROM 25 OCT TO 26 OCT (ACCORDING TO ONE OF SR'S STATEMENTS - FINDING BOMB SAT EVENING OR SUNDAY MORNING), SECOND, SHAY SR WAS - ACCORDING TO WITNESSES - ON 25<sup>TH</sup> NIGHT (12M AT STORE 24 - QUINCY) AND 26 NIGHT 4 WITNESSES PUT SR AT A PARTY IN QUINCY FROM 6-7 PM UNTIL APPROX 10 PM.

AND SEE HIM (JR) LEAVE AROUND 12:30 AM AND ANOTHER WITNESS SEES HIM BETWEEN 1 AM - 3 AM AT A STORE 24 IN QUINCY. JR'S MOTHER PUTS JR AT HOME (THE FALLS) DURING THE DAY - SUNDAY, AND SUNDAY NIGHT A WITNESS PUTS HIM AT STORE 24. IF THE FATHER FOUND THE DEVICE SATURDAY NIGHT, SIMM JR WOULD HAVE TO OF PUT THE DEVICE ON THE CAR SOMETIME BEFORE 6 OR 7 PM ON SATURDAY NIGHT. SATURDAY THE 26TH I WAS AT THE OFFICE AND PICKED UP JOHN CATES AROUND ~~AT~~ 3:30-4 PM AT THE BRAWTRICE T. I REMAINED WITH JOHN CATES UNTIL MONDAY THE 28TH MORNING.
