- 1) JR SAID HE NEVER TOLD CARRION WHERE I LIVED IN MILTON -

- 3) JR SAYS FEDS TOLD HIM (JR) THAT AL OFFERED GAETOR \$10 K TO KILL JR AND THE FEDS WERE HOLDING GAETOR
- 4) JR TOLD ME HE MADE UP THE STORY ABOUT THE QUINCY QUARRIES JUST TO TOY WITH THE FEDS. HE SAID HE PURPOSLEY LIED TO "SCREW" WITH THEM.
- 5) JR SAID HE KNOWS I DID NOT DO THIS, HE SAID THE FEDS AND FRANK ARMSTRONG PUT MY NAME INTO JR'S HEAD
- 6) JR SAYS THAT HE THOUGHT THE GUYS FROM B BOSTON DID THIS AND MENTIONED ABOUT HOW THE FATHER WAS FOLLOWED AROUND BY SOMEONE - WE HAVE THIS BRD REPORT.
- 7) JR SAID THAT HIS FATHER WAS MAKING MISTAKES IN HIS STATEMENTS - HE IS LOOKING GUILTY - A JR QUOTE.
- 8) JR'S SISTERS TOLD HIM (JR) THAT HE (JR) WAS SCREWING UP SR'S LAWSUITE
- 9) JR THEN STARTED TO BRAG TO THE OTHER PEOPLE IN THE LOCK UP ABOUT THE MEDIA ATTENTION HE HAS RECEIVED AND THAT HE (JR) WAS FAMOUS
- 10) JR SAID THE FEDS TOOK HIM TO THE QUINCY QUARRIES AND THEY WERE MET BY NAVY SEALS TO LOOK FOR PLASTIC BAG OF ITEMS IN SHAY'S STORY

- 11) JR SAID THAT CRITCHNER'S BROTHER, SHAWN DONLAP WAS OUT TO MAIL JR FOR THE 65K
- 12) JR SAID HE HEARD POLICE SUSPECTED ME AFTER THE POLICE DOG UP MY NAME THROUGH THE SE INCIDENT AND THE POLICE QUIZZED HIM ABOUT THE SE INCIDENT AND ABOUT MY NAME

- 15) JR SAID HE KNOWS THAT IF THE BOMB KILLED HIS FATHER THE LAWSUITE WOULD NOT GO THROUGH AND NO ONE WOULD GET ANY MONEY (YOU + I READ OTHER WISE + ALAN PRANSKY IN GG STATES IF SR DIED THE MONEY WOULD GO TO THE HEIRS)

- 17) SAYS THE INMATES THAT ARE TESTIFYING AGAINST HIM ARE LYING, THEY WANT THE 65K AND GET OUT OF JAIL FREE CARD AND THAT HE (JR) NEVER TOLD THEM (INMATES) ANYTHING THAT I AM READING ABOUT
- 18) TOLD ME THE LAST TIME HE SAW MY CAR WAS IN TOWN ON BOYLSTON ST WHEN HE PUT A BUNCH OF INVITATIONS TO SOME NIGHTCLUB ON THE WINDSHIELD OF MY TOYOTA IN JULY OF 91 (THIS WAS ON THE 1200 BLOCK OF BOYLSTON STREET - BOTH JOHN AND I REMEMBER THE PAPERS ON MY WINDSHIELD BUT UNTIL 25 JUNE 93 I NEVER KNEW WHO PUT THEM THERE)
- 19) DID NOT MENTION RADIO SHACK BUT SAID THAT ALL OF THOSE PEOPLE, ED CARRION, GEORGE NIGHTINGALE, DWAYNE AMBRISZAR, AND ALAN HINGSBURY ALL KNEW EACH OTHER AND ALL KNOW TOM SHAY JR FROM THE RAMROD BAR AND FROM GEORGE NIGHTINGALE'S APARTMENT.

21) JR SAID HE HAD ALL THE FILES I HAVE AND WANTED TO KNOW WHO DONNA SHEA WAS - I WOULD NOT ANSWER WANTED TO KNOW IF I KNEW ED CARRION I SAID I NEVER MET HIM, THEN HE ASKED IF I WAS SURE, THAT HE WAS A BIG GUY AND COULD NOT MISS HIM. I AGAIN SAID I HAD NO IDEA AND THAT I WAS TIRED AND TRYING TO SLEEP.

SHAY KEPT ON RAMBLING AWAY - IT IS NO SURPRISE AS TO WHY INMATES HAVE INFORMATION ABOUT SHAY, HE WAS QUOTING THINGS OUT OF THE DISCOVERY MATERIALS AND OPENLY TALKING ABOUT IT WITH THE OTHER INMATES IN THE FEDERAL LOCK UP.

ANOTHER INMATE TOLD ME (FROM MIDDLETON) THAT JR WAS A REAL IDIOT AND THAT HE WAS TALKING ABOUT HIS CASE IN DETAIL AND WOULD TELL ANYONE ANYTHING ABOUT THE CASE.

SHAY THEN STARTED AGAIN, HE SAID HE WAS ACCUMULATING LIGHTERS AND WAS GOING TO STICK THEM IN THE MICROWAVE AND BLOW IT UP.

FINALLY THE ATTORNEYS CAME FOR JR.
