LEAHY - TRANSCRIPT OF AWT TRIAL

LEAHY SAYS AL SAID, ON 4 FEB 92, "I'M NOT GOING TO MAKE UP" THIS IS DIFFERENT!

HOW CAN THE GOVERNMENT EXPLAIN THAT DEVICES THAT CONTAIN A SIGNIFICANT AMOUNT OF ^{PHYSICAL} SIMILAR ITEMS, ARE LESS SIMILAR TO THE 91 DEVICE THAN THE 86 DEVICE WHICH CONTAINS MORE DISSIMILARITIES THAN SIMILARITIES, AND WHY ~~WOULDN'T~~ DOESN'T THE EXIS REPORT REFLECT THIS FACT.

DEMMY HLINE TESTIFIED THAT HE PERSONALLY WORKED ON DEVICES WITH ROUND, DONUT SHAPED MAGNETS / WOOD / TOGGLE SWITCH / FOTABA / SOLDERED, TWISTED WIRES / BLASTING CAPS / DYNAMITE / AA BATTERIES / GLUE / PLACED UNDER VEHICLES / AUTOMOBILES. THE GOVERNMENT CONCLUDES THAT THESE DEVICES WITH MORE ^{PHYSICAL} SIMILARITIES THAN DISSIMILARITIES ARE LESS LIKE THE 91 DEVICE AND THE 86 DEVICE WITH GENERIC SIMILARITIES, NOT PHYSICAL, AND MANY PHYSICAL DISSIMILARITIES IS SAID TO BE JUST LIKE THE 86 DEVICE. WHEN WASHROM WAS SHOWN THE PALLWIN PRESS BOMB BOOK THAT CONTAINED AN ALMOST IDENTICAL CIRCUIT AND DESIGN COMPARED, TO THE 91 DEVICE, WASHROM STATED THAT IT CONTAINED THE 3 BASIC DESIGNS OF A R/C BOMB. I BELIEVE HE STATED THE DIFFERENCE WAS A FLAMENT WAS USED BY THE SERVO TO TOGGLE SWITCH SET UP. - ONLY DIFFERENCE HERE IS THE SERVO IS USED TO PULL THE TOGGLE SWITCH INSTEAD OF PUSHING THE TOGGLE SWITCH AS IN THE 91 DEVICE. HE STATED THAT THE DESIGN DID NOT SHOW ANY ~~END~~ END OF CONTAINER, AND THIS WAS A SIGNIFICANT

DIFFERENCE - 86 HAD NO CONTAINER - THIS MUST ALSO BE DIFFERENT.

HE SAID THE OTHER DIFFERENCE WAS A SINGLE BLASTING CAP WAS USED VERSUS A DUAL CAP ARRANGEMENT AS IN 91 - THE 86 DID NOT EVEN USE A BLASTING CAP, A SIMULATOR SO THIS MUST BE TWO DIFFERENCES ~~AND~~ COMPARED TO THE 91 DEVICE.

THE POINT - IF THE PALLADIUM PRESS VERSION OF AN R/C BOMB HAS THE SAME COMPONENTS AND SET UP AS THE 91 ~~AND~~ WASHROM IS SAYING THAT THESE MINOR VARIATIONS ARE MUCH DIFFERENT THAN THE 91 DEVICE, HOW CAN HE SAY THE 86 DEVICE IS IDENTICAL.

TOGGLE SWITCH - PALLADIUM HE IS SAYING THAT THE SERVO PULLING THE TOGGLE SWITCH WITH A FILAMENT IS NOT SIMILAR TO THE 91 DEVICE TOGGLE BEING PUSHED BY THE SERVO. THEN HE SAYS THAT THE 86 TOGGLE SWITCH IS MANUALLY THROWN, IN THE FIRING CIRCUIT, AND THEREFORE THIS SETUP IS MORE SIMILAR TO THE 91 THAN THE PALLADIUM PRESS SETUP. (YOU HAVE TO PUT TOGETHER WASHROMS 1ST + 2ND TESTIMONY) BUT LOOK AT IT - THE PALLADIUM PRESS VERSION IS MUCH CLOSER TO THE 91 VERSION - SERVO ACTIVATED TOGGLE SWITCH - THAN THE 86 VERSION - MANUALLY THROWN TOGGLE SWITCH, ~~AND~~ WASHROM DENIES THIS.
