EARLIER IN THE WEEK RICH, NURDAN, DAVE AND MYSELF WENT TO HENT'S CARPETLAND TO SELECT AND PURCHASE THE CARPET FOR THE OFFICE BUT THEY WOULD ONLY ACCEPT CASH OR CERTIFIED CHECK. WE THEN DEFERRED THE PURCHASE UNTIL RICH PICKED UP THE VAN TOWARD THE END OF THE WEEK. ALSO RICH WENT TO BJ'S WHOLESALE IN WENMOUTH, TO JOHN DISTASIO'S HOUSE AND GIVE HIM \$ 60 FOR OFFICE FURNITURE. 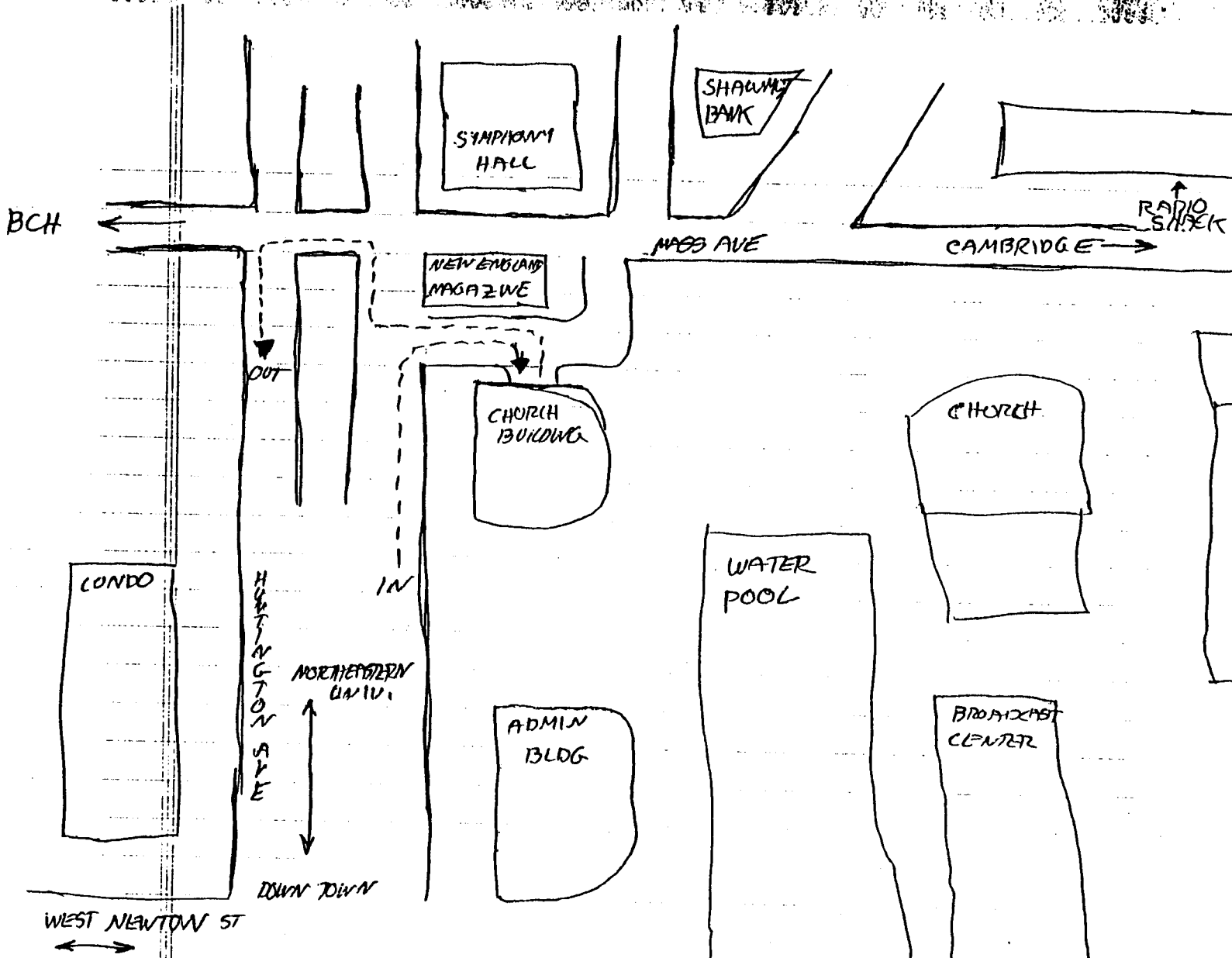
