JOHN LAMBERT - A PC UNIT INMATE THAT HAD HIS LEGAL PAPERS EXAMINED BY MR DESMOND AND MR MAUC WHILE MR LAMBERT WAS IN COURT THE SAME DAY I WAS IN FEDERAL COURT I DON'T THINK THIS PERSON WOULD HAVE THE MENTAL CAPACITY TO TELL A CONVINCING STORY AGAINST ME - BUT WHO KNOWS.

IT APPEARS OBVIOUS THAT AUSA PAUL KELLEY HAS NOTHING THAT CAN BE CORROBORATED AGAINST ME AND THAT IT IS ALSO OBVIOUS THAT BY PLACING ME AT PHOC HE IS EXPOSING ME TO DESPARATE PERSONS LOOKING FOR ANY TYPE OF "DEAL" TO IMPROVE THEIR SITUATION IN LIFE AS THE CASE IS HERE. I REFER TO THE CASE OF EDWARD F DESMOND, A MAN INVOLVED WITH TWO DIFFERENT CASES AND RECENTLY ~~WAS~~ CONVICTED AND SERVING 97 MONTHS. THIS MAN IS INVOLVED WITH SEVERAL FEDERAL AGENTS AND PAUL KELLEY. THIS MAN HAS ATTEMPTED TO SOLICIT OTHER ~~TO~~ INMATES TO GATHER INFORMATION ABOUT OTHER INMATES AND OR THEIR FRIENDS ON THE OUTSIDE OF THE PRISON SYSTEM. AS WITNESSED BY DAVID MEGERY, A FELLOW INMATE SERVING TIME AT PHOC, EDWARD F DESMOND WAS WITNESSED GOING THROUGH MY LEGAL PAPERS, ~~AND~~ TAKING THEM TO A COPY MACHINE AND SHOWING THE COPIES TO INMATES IN THE PC SECTION, ALL DURING A DAY WHILE I WAS IN FEDERAL COURT. FURTHER IT WAS WITNESSED THAT MR DESMOND WOULD RECITE INFORMATION DERIVED FROM MY LEGAL PAPERS AND ADDED TO IT THAT I TOLD HIM I PARTICIPATED IN THE 91 CRUMB AND THAT I WAS BRAGGING ABOUT IT. ALSO A MR MAUCK WAS WORKING WITH MR DESMOND IN AN ATTEMPT TO GATHER INFORMATION ~~FROM ME~~ ABOUT ME. IN A NOTE HANDED TO ME BY A CURTIS HOWARD, A PHOC INMATE, ~~BY ED DESMOND~~ CONCERNING MR DESMOND IN AN ATTEMPT TO MAKE A "DEAL" CONCERNING A "MUNITION DEAL" ~~BY~~ BETWEEN AN OUTSIDE ~~CRIMINAL~~ AND ~~BY~~ A FEDERAL AGENT, IN THE NOTE MR DESMOND SAYS HE WOULD BE MEETING WITH PAUL KELLEY AND OTHER ATF AGENTS, ALL OF WHOM ARE INVOLVED WITH MY CASE ~~AND~~

WHILE BEING TRANSPORTED TO FEDERAL COURT IN MARCH I WAS WITH SEVEN TO TEN OTHER INMATES, ONE OF THEM IDENTIFIED AS MR GATOR. MR GATOR IMMEDIATELY KNEW WHO I WAS BOTH FROM TV AND PRINT MEDIA. HE TOLD ME HE KNEW DETAILS ABOUT THE CASE SUCH AS 2-3 STICKS OF DYNAMITE, ~~AND~~ BLASTING CAPS, ~~AND~~ REMOTE CONTROL DEVICES, THE DEATHAM ~~OR~~ GARAGE THAT SHAY SR ~~OWNED~~ ^{RENTED} AND THAT HE KNEW WHO WAS INVOLVED AND THAT HE KNEW IT WAS NOT ME, FURTHER, THAT HE WOULD NOT GIVE INFORMATION AGAINST HIS FRIENDS. MR DESMOND ALSO KNOWS MR GATOR.

I ALSO HAD BEEN TOLD BY NUMEROUS INMATES THAT MR DESMOND WAS ASKING PEOPLE IF I HAD TOLD THEM ANYTHING USEFUL THAT COULD BE USED AGAINST ME AND IF THEY HEARD ANYTHING TO TELL HIM (DESMOND) AND HE WOULD PAY THEM FOR THE INFORMATION.

BASED ON THIS, I FEEL, AND IT IS OBVIOUS, THAT BEING AT PHOC PLACES ME IN JEOPARDY, CASE IN POINT ~~AND~~ THE ALLEGED WITNESS THAT PAUL KELLEY ~~INSISTS~~ INSISTS HE HAS ONLY RECENTLY "DISCOVERED" AND SINCE I HAVE BEEN INCARCERATED FOR OVER 5 MONTHS

I ~~BEFORE~~ AM CONVINCED THAT THE PERSON IN QUESTION IS AN INMATE HERE OR THAT WAS HERE AND RECENTLY TRANSFERRED. I BELIEVE THIS TO BE EITHER MR MALICK, MR DESMOND, ^{OR} MR LAMBERT. OR IT COULD BE MR GATOR WHO STILL IS AT PHOC. THE ONLY OTHER POSSIBILITIES WOULD BE INMATES BEING TRANSPORTED TO OR FROM FEDERAL COURT WITH ME.

IT SEEMS FAIRLY OBVIOUS THAT THE GOVERNMENT IS RELYING HEAVILY ON THE PRISON SYSTEM FOR "EVIDENCE" AGAINST ME. I CITE THE "STORIES" THAT SHAM JR TELLS INMATES, THOUGH PROVEN UNTRUTHFUL AND NOT CORROBORATABLE (SP?) ~~AND~~ THESE RELATED STORIES SEEM TO BE OF USE TO THE GOVERNMENT INCLUDING STATEMENTS FROM SHAM JR'S IMAGINATION, THAT SEEM TO CHANGE AS TIME GOES ON. I POINT TO STATEMENTS BY MR EVANS AT PHOC AND OTHERS AT DEDHAM JAIL.

THE GOVERNMENT DOES NOT SEEM TO BE RELYING ON PHYSICAL EVIDENCE WITH THE EXCEPTION OF A SWITCH PURCHASED BY SHAM JR AT A RADIO SHACK THAT WAS SUPPOSED TO BE PART OF THE 91 DEVICE. IN FACT THIS SWITCH DIFFERS FROM THE ONE FOUND IN THE REMAINS OF THE 91 DEVICE. SO NOW THERE IS NO PHYSICAL EVIDENCE THAT LINKS EITHER SHAM JR OR MYSELF TO THIS CRIME. THE ONLY THING THAT THE GOVERNMENT SEEMS TO BE ABLE TO USE ARE THE STATEMENTS OF SHAM JR'S THAT HE KNEW NOTHING ABOUT THE BOMBING UNTIL AFTERWARDS AND THAT I TOLD HIM THAT I DID IT FOR HIM AS A SURPRISE BECAUSE OF HIS FATHER. THE GOVERNMENT ALREADY MIXED THIS IDEA, THE SAME AS ON THE 36 TAPE.

IT HAS ALSO BEEN RELAYED TO ME THAT TOM SHAM JR HAD SPENT TIME IN THE PC UNIT WITH SOME OF THE INMATES THAT ARE CURRENTLY HERE

ALSO RELAYED TO ME, BASED ON A LETTER AN INMATE RECEIVED ~~FROM~~ FROM MR DESMOND, MR DESMOND IS WORKING WITH SOMEONE AT THIS PRISON, BUT MR DESMOND WOULD NOT GIVE OUT HIS NAME.
