ALSO I HAVE INCLUDED SOME PAYSTUBS FOR WHEN BRIAN WORKED FOR GREENVIEW LANDSCAPE AS A CARPENTER DURING APRIL AND MAY. THIS WAS ALSO THE TIME BOB AND I WERE WORKING AT GREENVIEW AND LIVING AT 278 NANTASKET AVE. UP UNTIL MAY OF 89, GREENVIEW'S OFFICE WAS LOCATED ON THE FIRST FLOOR OF WHERE BOB AND WERE LIVING.
