ON MONDA MORNNG 10-28 HE DROVE HIS BUICK OUT OF THE DRIVEWAY AND HEARD A SCRAPING. HE THOUGHT HE WAS BOTTOMING OUT. OBSERVING THE ARTICLE AGAIN (CONFUSING - WHEN DID HE ACTUALLY "SEE" THE BLACK BOX?) HE PICKED IT UP AND EXAMINED IT AND THREW IT UP AGAINST THE HOUSE.

SHAY SR STATES THAT ON SATURDAY NIGHT HE BACKED HIS AUTO INTO HIS DRIVEWAY AND FELT HIS CAR BOTTOM OUT.

SHAY SR STATES THAT ON SUNDAY HE PULLS HIS CAR OUT OF HIS DRIVEWAY AND FELT THE SAME BUMP. HE GOT OUT OF HIS CAR TO SEE WHAT HAPPENED TO HIS CAR. AT THIS TIME HE STATES HE FOUND A BLACK OBJECT

SHAY DESCRIBES OBJECT AS A PIECE OF WOOD TEN OR 12 INCHES LONG AND ABOUT FOUR OR FIVE INCHES WIDE. ON THE TOP OF THE WOOD HE SAW SMALL MAGNETS ON EACH END AND TWO LARGE DISKS IN THE MIDDLE OF THE WOOD. ON THE RIGHT SIDE HE SAW A SMALL BLACK BOX WITH TWO WIRES STICKING OUT AND THIS WAS ON THE UNDERSIDE OF THE WOOD. HE SAID MAGNETS WERE GLUED ON. HE SAID THERE WAS ONE BROKEN WIRE AND SAID HE WAS SURE IT WAS FRAYED

- 10-28 GOES INSIDE HOUSE - CONCERNED RETURNS TO BLACK BOX
- 10-28 PICKS UP BLACK BOX AND THROWS IT UNDER FRONT OF CAR
- 10-28 SHAY SPEAKS TO MEZHANKS
- 10-28 SHAY GOES TO POLICE
